To achieve recognition at the Certificate III level, the candidate must demonstrate competency in the **twelve core units, plus three electives (total fifteen units)**. Up to two of the required electives may be selected from other qualifications aligned at the Certificate II, III or IV level in this Training Package or from other relevant endorsed Training Package qualifications aligned at the Certificate II, III or IV level (with a maximum of one unit from Certificate II).

This qualification should be held by all persons involved in the Investigations process within any organisation including, fraud managers, internal investigators, section heads, field agents, investigation claims and standards monitoring officers who vet investigation related reports, OH&S Consultants, Psychologists who conduct Workplace Investigations, OH&S Managers & Safety Officers and so on.
